Chief Executive's report - 20 March 2019

1. Meetings attended

A list of the meetings attended since the last Council meeting is attached. I have set out below a summary of two particular meetings.

Professional Standards Authority conference

This research and academic conference is attended by all the health and care regulators as well as international regulators, academics and education stakeholders. The theme this year was 'What is it to be a good regulator' and there were a range of sessions which focused on systems, ethics and common traits of good regulators.

NHS Education for Scotland (NES)

We met with NES to discuss in more detail their request to seek an extension to the timetable for the implementation of SET1 in relation to paramedic programmes.

2. Key updates to highlight to the Council

The following is a key update for the Council's attention.

Proposals to increase the registration fees

Following the Council's decision, we have been monitoring reaction. The trade unions and some professional bodies issued press releases and there has been coverage in several professional journals. This has tended to follow the line taken by the unions criticising the decision. However, a number of the professional bodies have been more balanced and used our statement highlighting the key messages.

Immediately following the decision, the unions started to encourage their members to contact their MPs. This has resulted in letters directed to us, an Early Day Motion and written questions in parliament. In response to the written questions, the Government has stated that 'HCPC registration fees will remain the lowest of any of the United Kingdom-wide health and care regulators. Registration fees are tax-deductible and this fee rise will amount to just over £1 a month extra for most of the HCPC's registrants.' We are monitoring the EDM and responding to parliamentary letters as they arrive. We have also provided a briefing note to the Cabinet Secretary for Health & Sport in Scotland.

Following the initial reaction on social media, where we were directly tweeted by approximately 40 people, social media activity is now limited.

We will continue to monitor reaction and respond appropriately.
